Known or Anticipated Hazardous Products of Combustion: Emits toxic fumes under fire conditions.

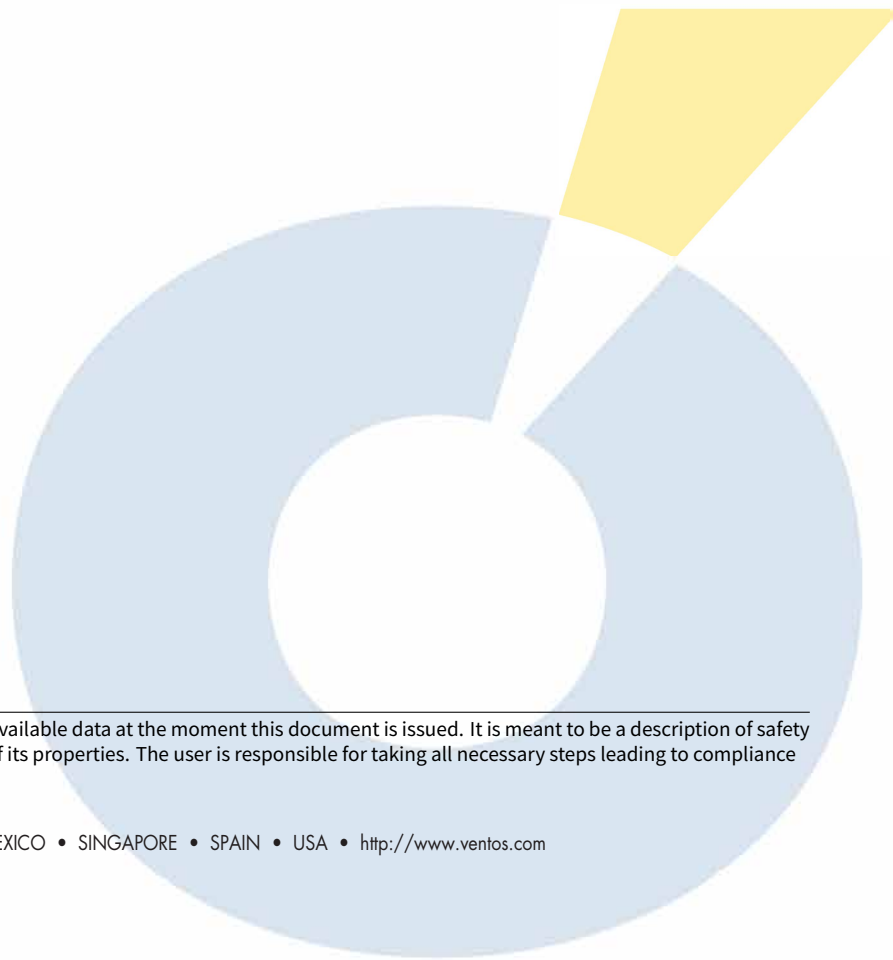
