4. FIRST-AID MEASURES

4.1. Description of necessary first aid measures

Ingestion: Rinse mouth with water.

6. ACCIDENTAL RELEASE MEASURES

Avoid open flames or sources of ignition (e.g. pilot lights on gas hot water heater).

Ventilate area and wash spill site after material pickup is complete.
